

### **Terms and Conditions: DirectAxis Pulse Cape Town City jersey competition**

1. This promotional competition is conducted by DirectAxis, a business unit of FirstRand Bank Limited ('the promoter').

3. By participating in the competition, you agree and accept to be bound by the competition rules contained herein.
4. The promoter will start promoting entry into the competition from 30 April 2020 to 31 May 2020.
5. Eligible participants for the competition are defined as: Someone who is a member of the Cape Town City FC email database and is a new DirectAxis Pulse subscriber (i.e. subscribed to DirectAxis Pulse between the period of 30 April 2020 to 31 May 2020)
6. Qualifying participants do have the option to opt-out at any stage during the competition.

8. The prize will be one of 4 sets of 2020 official match replica jerseys of Cape Town City FC. Each set contains 4 replica Cape Town City FC jerseys. The jerseys will be available at latest one month into the 2020/21 PSL season. Winners are eligible to win 1 set of jerseys only. The jerseys will not include printing of names or numbers. At the promoter's discretion they may add additional prizes.

  - a. residents of the Republic of South Africa; and
  - b. 18 years or older.
  - c. A member of the Cape Town City FC email database
