	In these rules we refer to the above promoter(s) as "the promoter(s)" or "DA". We refer to participants and winners as "you".

	Competition closes on the week of 13 December 2024: 08:00am

	The promoter(s) reserve the right to extend the competition. Notice of this will be posted in these rules.
What is the prize?	Winners will win a weekly R5000 cash prize sent electronically via EFT to a verified bank account or paid through electronic wallet/money transfer solution.
Winner/s announced on:	Winner will be announced live on-air during each week of the competition.
Eligibility: Who qualifies to take part?	This competition is open to all individuals over the age of 18 who live in the Republic of South Africa. The individuals must hold a valid South African (SA) ID or a valid SA passport.
Who cannot take part?	The following persons may not take part in this competition even if they qualify to take part. They will forfeit (give up) any prizes awarded to them:

#### **General Rules**

#### **IMPORTANT – PRIVACY MATTERS**

Participants in this competition understand and agree that for us to offer this competition, we may collect and use personal information about participants. This personal information may include your first name, last name, email address, mobile number, ID number and in certain instances your <u>image</u>. - DA must receive your entry before the published closing date and time. DA must also receive your entry in the
  correct format. You will lose the right to take part or claim any prize that may have been awarded to you if you
